49. APOLOGIES FOR ABSENCE

50. ADDRESS BY MOIRA SAUNDERS CONCERNING DOG CONTROL ORDERS

Moira Saunders gave a short address concerning Dog Control Orders. She circulated to Members the reasons why she believed that all dogs in Pembroke Dock should be on leads in public areas: i.e.

- reduction of the problem of dogs fouling public areas;
- prevention of dogs causing road traffic accidents;
- ensuring that dogs could not easily attack a child or another animal;
- protecting areas of 'special wildlife' from fouling and disruption by dogs.

She asked Members to support her views on Dog Control Orders, which were discussed later in the meeting under Minute 56(a) – Verbal Report of the Town Clerk.

Following her presentation she invited questions or comments from Members.

53. MATTERS ARISING FROM THE MINUTES

(a) Minute 38(49) – Application for Biodiesel Facilities at Thornton Industrial Estate, Milford Haven

The Town Clerk advised that he had received a letter from Pembrokeshire County Council saying that no application had been received so far, but that the Town Council would be consulted if and when an application was received by them.

(b) Minute 39(57) - Reception for Members of the Pembroke School Netball Team

The Town Clerk advised that he had received a telephone call from Mrs. Diane Morris thanking the Town Council for the reception that had been arranged for the Netball Team members. She was very grateful for the hospitality that had been extended to them.

(c) Minute 40 – Verbal Report of the Town Clerk re Town Green Status of land between Stranraer Road and Military Road

Councillor Mrs. C. Fortune read out a letter from the Pennar Residents Association which requested the Town Council's support in attaining Town Green Status for the land between Stranraer Road and Military Road.

Councillor D. Jones reiterated his concern that the majority of people in the town had been in favour of the previous plan of a Marina in the eastern sector of the bay but at present people were concerned about the development of housing which was being proposed.

Councillor S. Perkins said that there had been reports implying that the Town Council were timewasting in not making a decision regarding this application, and believed that people may have misunderstood the concerns of the Town Council in that they wanted to get the best that they possibly could for the town of Pembroke Dock and had been concerned that no money was being put into the Town Centre itself.

The Town Clerk suggested that Mr. Keith Williams be invited to talk to the Town Council about a possible section 106 agreement.

**62. Public Services Ombudsman For Wales Report In Respect Of The
2006/7 Year.**

The Town Clerk had placed a copy of the Ombudsman's report for the above year on the RHS table in the Chamber for members' perusal.

63. Chieftain Tank And Sunderland Aircraft Prop.

The Town Clerk reminded Members that sometime ago he had asked the Youth Offending Team to come and repaint the tank. The condition of the tank was now such that some of the metal work was showing further signs of decay and some remedial work was urgently

66. Report Back On Meeting Of Memorial Park Sub Committee.

The Minutes of the Meeting of the Memorial Park Sub Committee held on 23rd July 2007 had been circulated to Members.

Councillor S. Perkins advised that before that meeting she had met with Ian Westley, and that Pembrokeshire County Council were very keen to see the Memorial Park Committee progress. A meeting had been arranged to take place in the beginning of September, at which the Action Plan which had been set up would be progressed. Security, footpaths and funding for a Warden were among the priorities to be discussed at the next meeting, but it was felt that matters were progressing satisfactorily.

67. Portable Appliance Testing.

The Town Clerk advised that this was recently carried out and that one of the printers for the computer system had failed the test. He therefore requested permission to purchase a replacement small printer and also a new printer for his portable machine.

68. Mid And West Wales Fire And Rescue Authority Draft Risk Reduction Action Plan 2008/9

The report had been circulated to members in time for this meeting. The consultation period ended on 14th August 2007. There were two questions to which responses were requested and the Town Clerk requested for an indication of what should be included.

Question 1. A proposal to change the way in which we deliver our Services to reduce risk in the upper Swansea and Amman Valley areas

Councillor S. Perkins said that she was totally against anything resulting in reductions of night cover in any area.

Members agreed that as they were not familiar with the area, they felt that they were unable to comment, however they noted that services appeared to be improved by the provision of a new station.

Question 2. Changes we may make to duty systems for a number of our staff.

Members believed that currently there was adequate provision of services for the safety of the public, and that it was reasonable that these be reviewed from time to time to see if the current duty system can be improved.

The Town Clerk agreed to respond to the Consultation accordingly.

69. Rights Of Way Improvement Plan For Pembrokeshire

Comments on the above report which had been prepared by Pembrokeshire County Council and the National Parks Authority were requested. The consultation period ran until 27 September 2007 and the Town Clerk suggested that the report was circulated to members during August with a response being formulated at the meeting to be held on 30th August 2007, to which members agreed.

70. Casual Vacancy.

The Town Clerk reminded Members that a casual vacancy had been advertised in the Western Telegraph newspaper and also advertised in some shops, the library and church/chapels etc within the town. He had received one application to be considered for co-option. The applicant was as follows:-

71. Changes To The Emergency Dental Service

The Town Clerk had received notification from the Pembrokeshire Local Health Board that with effect from 7 July 2007 a service would be provided on Saturday at Winch Lane Health Centre and on Sunday at Tenby Cottage Hospital. An appointment would be necessary and this could be obtained by telephoning 0845 60 10 128.

This information was provided to update members.

72. Wales Rural Observatory Services Questionnaire.

The Town Clerk had received a questionnaire to be completed by Town and Community Councils throughout Wales relating to the provision of services. Many of the questions were straightforward but some required a qualitative answer.

Members agreed that completion of the document should be deferred until the next meeting of the Town Council on 30th August 2007.

73. Purchase Of A Refurbished Radar Gun.

The Town Clerk had received a letter from the Dyfed Powys Constabulary concerning the purchase of a refurbished radar gun. The cost would be £850 plus £13 postage costs. The budget for Crime Prevention initiatives stood at £1000.

Members agreed that speeding traffic throughout the town was a serious concern which had been prioritised, and it was confirmed that a radar gun, if purchased, would be for the sole use of Pembroke Dock.

74. Voices Of Pembroke Pre Visit To Malta Concert

Members were reminded that the Voices of Pembroke Choir would be visiting Malta from 1st to 8th October this year. They had arranged a fund raising concert at Monkton Priory Church on Friday 14th September starting at 2000hrs (8.00pm). In view of the support this Council had provided for the tour in Malta the Choir had offered members of this Council complementary tickets for the occasion.

Members were asked to contact the Town Clerk if they wished to have tickets for the concert.

75. Blocked Drains And Gulleys Within Pembroke Dock.

The Town Clerk attached at Appendix C a copy of an e mail he had received from a local resident, Mr D King, about the above topic. He reminded members that the problem of the drain at the bottom of Lewis Street had been an ongoing issue for some time. The drain had already been cleaned on two occasions to his knowledge this year. The unprecedented rainfall of over 2” on Friday 13th July would have caused excessive water entering the gulleys and drains. The Town Clerk had e mailed the County Council about the matter once again and received an acknowledgement to his enquiry.

The matter had been brought to Members’ attention so that they were aware of the issues in this case. The Town Clerk had sent a reply to Mr King.

The Town Clerk advised that PDEAT were pursuing this matter as to how regularly the drains are cleaned within Pembroke Dock.

Councillor S. Perkins said that she supported this, and this matter should be pursued.

The Town Clerk advised that he was still awaiting a definitive reply from the County Council to the question of how many times the drains are cleaned.

76. Pembroke Dock Midsummer Festival

The Town Clerk had received a certificate of thanks from the group in respect of the support given by the Town Council. Members were asked to note that the group received over £2000 by way of a donation and in accordance with section 137A of the Local Government Act 1972 he was awaiting sight of the Accounts for the group to show how the money had been spent.

77. Requests For Financial Assistance.

The Town Clerk had received the following applications for financial assistance:-

(a) Shelter Cymru.

The Town Clerk advised that this was a national organisation which was seeking grant aid towards their work of providing housing advice and assistance to those who were homeless or in poor housing. In their application they stated that they held surgeries in this town every Thursday from 1400 to 1600hrs. The accounts for the organisation were in order. The Charity received a donation of £50 in 2004 towards the cost of providing the surgeries in the town.

A decision on this application was requested.

Members noted that weekly advice surgeries were held at the CAB in Pembroke Dock, but that taking into account Shelter's current financial assets and the current Town Council budget for financial assistance to voluntary/charitable bodies, it was decided that on this occasion no grant would be payable.

(b) Urdd Gobaith Cymru.

The Town Clerk advised that this was a national organisation which offered a wide range of cultural, sporting, educational and philanthropic activities to young people. Most of their groups were associated with schools and within Pembroke Dock there were 41 children who were members who attended Pennar Junior School, 51 who attended Pembroke Secondary School and 21 attended St. Mary's RC School. The cost of running the Pembrokeshire County section was approximately £48,500 per year. Pembrokeshire County Council provided some of this cost but there was a shortfall of some £6,283. A donation towards this shortfall was requested.

The accounts for this organisation were in order.

A decision on this application was requested.

Members noted that there were a number of individual groups centred on schools within the town there was no specific benefit to them. They would prefer that any application for grant aid came from one of these groups, provided it was for the assistance of the group within the town in helping them carry out an activity which would enhance the group's work within the town or support them to take part in an activity outside the town.

It was therefore decided that no grant would be payable.

78. Appeal by Mr J B Hopkins Concerning Site at Thorn Cottage, Beach Road, Llanreath.

Members were reminded that the Planning Inspector had recently dealt with an appeal in respect of the above site. The result of the appeal was that the appeal was dismissed and planning permission was refused. Full details of the decision was recorded on the letter issued on 4 July 2007 which had been placed on the RHS table in the chamber for members to peruse.

79. Signage at The Pembroke Port Entrance to the Dockyard.

The Town Clerk attached at Appendix B a copy of a letter he had received from Mr David Davies of the Townscape Heritage Initiative concerning the number of advertising hoardings at that entrance. The person who made the enquiry had been concerned as to whether planning permission had been obtained given that the boards had been placed on a listed wall / entrance.

55. SUPPLEMENTARY REPORT OF THE TOWN CLERK

82. Recess Sub Committee.

Members were asked to consider the composition of this Committee which will be dealing with urgent and planning matters in the summer recess period. At present the Planning Sub Committee consists of:-

Councillor Ted Hissey

Given Councillor Hissey's current absence because of medical treatment, members were asked if they wished to appoint a substitute until Councillor Hissey returned from sick leave.

Members agreed that the Recess Committee should comprise the same members as the Planning Sub Committee.

83. Alternative Life Styles Shop.

The Town Clerk advised that this property was situated in Commercial Row, Pembroke Dock. It had been drawn to the Town Clerk's attention that items which were not normally expected to be displayed outside the premises were clearly visible from the road. Concerns had also been expressed as to whether the shop was subject to the provisions of the Local Government (Miscellaneous Provisions) Act 1982 Schedule 3. It was understood that the County Council had been consulted in the past and it had been considered that this provision did not apply since the business did not consist to a **significant** degree of selling, hiring, lending, displaying or demonstrating –

(a) sex articles

The definition of the word “Significant” meant more than “more than trifling”; in deciding whether an establishment was a “sex shop”, the ratio between the sexual and other aspects of the business would always be material, so also would be the absolute quantity of sales, and the character of the remainder of the business.

Members’ instructions as to whether they wished to refer the matter again to the County Council were requested.

Members expressed their concerns and felt that it was unacceptable for such items to be displayed outside the premises. It was agreed that the Town Clerk should write to Pembrokeshire County Council stating the Town Council’s deep concerns regarding this matter.

84. Unauthorised Encampment Of Caravan(s) Off Pier Road, Pembroke Dock.

The Town Clerk had been advised that a gypsy caravan had been placed on land belonging to the County Council off Pier Road / Stockwell Road, adjacent to the former Kwik Save Store. The County Council had commenced possession procedures with the Courts.

The Town Clerk understood that this was becoming a problem within Pembroke Dock and that possession proceedings could be drawn out.

Councillor S. Perkins said that this situation is one which occurs year after year and it should be managed as a problem which affects areas of the whole town. She felt that a meeting should take place between the Town Council, representatives from Pembrokeshire County Council and the Police to address this problem.

Councillor D. Jones said there was also a problem with lorry trailer units being parked in the town.

Councillor R. Watts stated that this problem had gone on for some time. He said that MHPA were negotiating for a piece of land to be developed as use for a lorry park.

85. Synthetic Ice Rink 14 &15 December 2007.

The Town Clerk requested authorisation to pay for a limited amount of advertising in respect of the above event. Initially he sought authorisation for an advertisement in a Quarterly Magazine "Raring 2 go" which was to be distributed within Pembrokeshire and part of Carmarthenshire to schools, libraries, health centres etc. The cost would be £39 for a eighth of a page initial advert (autumn) and £79 plus VAT for a quarter page advert (winter).

Members gave their approval for the advertisement.

86. Purchase Of Small Generator.

The Town Clerk advised that in view of the fact that it was hoped that the Synthetic Ice Rink would be situated in the Western Way Car Park, it would be necessary to have an electric power system etc for the lighting and rink etc. He therefore requested permission for the purchase of a Generator. The cost was likely to be in the region of £250. The generator would be suitable for any other external function the Town Council organised which would require an electricity supply e.g. (any event in the Park etc).

Approval of this expenditure was sought.

The Town Clerk stated that to meet the cost of the town flag and memorabilia he would need to transfer money from underspends such as bunting.

Councillor R. Watts reported on his attendance at a meeting of PALC the previous evening.

59. ANY OTHER BUSINESS

(a) Record of Town Councillors' attendance at Meetings

Councillor S. Perkins suggested that a record of Members' attendance at Town Council meetings should be publicised.

The Town Clerk said that at the September meeting, the Town Council would be looking at those Members who serve on outside bodies and whether some individuals were doing more than others. A record of this could be included in an Annual Report.

(b) Parking of Lorries at top of North Street

Councillor Mrs. C. Fortune reported that lorries were being parked on private property at the top of North Street. This matter had been reported to Pembrokeshire County Council previously, but they were unable to do anything because of it occurring on private ground.

The Town Clerk said that he would write to the County Council again and would check with Simon Preddy as to whether this could be dealt with by his office, as this constituted an 'eyesore' in the town.

(c) Large Hole in tarmac in Focus DIY Car Park

Councillor Mrs. C. Fortune reported that there was a longstanding problem regarding the tarmac in the Focus DIY Car Park which needed repair.

The Town Clerk said that he would write to Morbaine Ltd. regarding this matter.

(d) PCSOs – Fixed Penalty Tickets

Councillor R. Watts said that apparently Pembrokeshire County Council had not issued the fixed penalty tickets to the PCSOs. This matter would be taken forward to the next PCSO meeting on 1st August.
